

Sunrise Monster Terms and Conditions

Eligibility

The competition is open to all residents of Gauteng, South Africa, who are aged 18 and above, excluding employees of Medihelp and their immediate family members.

Competition period

The competition begins on 23 January 2024 and ends on 29 February 2024. Entries submitted outside of this period will not be considered.

Entry method

Participants must visit the Medihelp website and locate the hidden monsters as indicated in the promotional materials. Upon finding a monster, participants must click on it and complete the entry form. It is each participant's responsibility to ensure that all information provided on the form is accurate, complete, and up to date.
